I hereby make application for membership in the Chester Recreational Association on behalf of myself and dependent family members residing in my household. I have read and fully understand the following provisions of ARTICLE I - MEMBERSHIP, Section 1, of the Chester Recreational Association By-Laws:

Section 1 - A member is defined as anyone who has been elected to membership by the Board of Directors and whose membership has not been suspended or terminated by the Board of Directors. Election to membership shall be by favorable action of the Membership Committee (Board of Directors) on an application accompanied by the recommendation of another pool member (the Membership Committee). By such favorable action all persons listed in said application shall become a member unit, with each person entitled to use of all the facilities of the Association. IF THE MEMBERSHIP COMMITTEE ANTICIPATES UNFAVORABLE ACTION ON AN APPLICATION, IT SHOULD REPORT THE SAME TO THE BOARD FOR FINAL AUTHORITY. For the purpose of these by-laws, a member unit shall consist of the immediate family which is defined to include husband, wife AND/OR DEPENDENT CHILDREN (or dependent child) in the same domicile; and other, upon Board approval, who reside in the same domicile and are dependent upon the head of household.

ALL INFORMATION MUST BE PROVIDED. Also, you MUST have a sponsoring member and sign BOTH pages. Incomplete forms will not be accepted.

_____ Plan 1: **Entire initiation fee paid in first year.** Pay \$1,000 initiation fee plus \$320 annual dues.

_____ Plan 2: **Initiation fee paid over two years.** Pay \$1,500 initiation fee (\$750 each year for 2 years) plus annual dues (currently \$320).

Please note dues for senior citizens ages 65 and over are \$160 (one-half of the regular annual dues) and seniors ages 60-64 are \$214 (two-thirds of the regular annual dues). Initiation fees remain the same.
