I have read and fully understand the following provisions of ARTICLE I - MEMBERSHIP, Section 1, of the Chester Recreational Association By-Laws:

Section 1 - A member is defined as anyone who has been elected to membership by the Board of Directors and whose membership has not been suspended or terminated by the Board of Directors. Election to membership shall be by favorable action of the Membership Committee (Board of Directors) on an application accompanied by the recommendation of another pool member (the Membership Committee). By such favorable action, all persons listed in said application shall become a member unit, with each person entitled to use of all the facilities of the Association. IF THE MEMBERSHIP COMMITTEE ANTICIPATES UNFAVORABLE ACTION ON AN APPLICATION, IT SHOULD REPORT THE SAME TO THE BOARD FOR FINAL AUTHORITY. For the purpose of these by-laws, a member unit shall consist of the immediate family which is defined to include husband, wife AND/OR DEPENDENT CHILDREN (or dependent child) in the same domicile; and other, upon Board approval, who reside in the same domicile and are dependent upon the head of household.
